Trainees from across the United States and Canada include established: physicians, holistic practitioners of medicine, shamans, nurses, psychotherapists, artists, writers, and filmmakers. Diverse spiritual and wisdom traditions and practices and ethnicities are represented that offer a rich cultural and community incubator within which healing and peace-making ways are explored.

Training periodically includes Councils with other international peacemakers and experienced healers who deal with extreme traumas of war and gender-based violence such as:

In May of 1990, my sister and I won a landmark civil suit against our father, a former career FBI agent and nationally recognized child abuse expert—for child abuse that had occurred decades earlier. As a result of our action, doors were opened legally in this country for others to win access to the courts to have their cases heard. Our case was one of the first in the United States to receive a jury award that sent a message that child abuse has devastating, long-term effects that demand redress. A jury of six calculated the damages at \$2.3 million. Although we never received any sizable compensation from our father, we held him accountable as did the courts.

1990-Present (cont'd)

Public speaking, teaching and group leadership related to child abuse, sexual assault, domestic violence and other systemic abuses of power. Utilize various mass media to educate and promote constructive change in the way individuals, professionals, and society understand and address these serious social problems. This work relies on both professional and personal experience in dealing with power and violence. In response to childhood violence, all political, social, legal, and legislative action has been aimed at confronting, healing, and preventing cycles of violence that issue from abuses of power.

### *The Child Abuse Accountability Act*

Testified before U.S. House Sub-committee on Compensation and Employee Benefits chaired by Eleanor Holmes Norton (1994) on behalf of legislation initiated with Congresswoman Patricia Schroeder entitled: The Child Abuse Accountability Act.

President Clinton. This bill changed Federal law. Now Federal pensions can be garnished for child abuse judgments. Received public credit from Congresswoman Schroeder for bill's inception and passage.

*Bill to Prohibit Discriminatory Insurance Practices Against Victims of Domestic Violence.*  
Testified in 1995 before the Joint Insurance Committee in MA on behalf of this legislation and won amendment of this bill to include disability insurance discrimination against victims of violence. Legislation won passage 1995.
